Terms and Conditions

The Prize

- One 500-euro discount on any tour published on our website that is scheduled to run in 2022 or 2023.

Entering the Give-Away

- Participation is exclusively through the Facebook or Instagram platforms.
- Participation is free and requires:

On Instagram: Participants must do all of the following:

- 1) Follow the Fresco Tours Instagram page.
- 2) Like the 'Give-Away' Instagram post.
- 3) Post at least one comment tagging a friend.

On Facebook: Participants must do all of the following:
